Business Parks - Rick Norwood

- Active Prospects: 17 totaling 1,340 jobs and \$132 million investment.

- Spec Building # 2 in Waterford starting in Spring of 16

#### Knowledge Park – David Lawrence

- Sora Phelps Rock Hill LLC (master developer) and City of Rock Hill continue to work on a new Master Development Agreement and Financing Agreement. The agreements include items such as land purchase schedules (timing and prices), infrastructure investments (planned expenditures, timing, and financial requirements), and credit enhancement for debt issuance, project ownership structures, and planned uses for TIF funds. Key dates in this process include:
  - April 5<sup>th</sup> Planning Commission approved the Development Agreement
  - April 11th City Council approved (first reading) Development Agreement/Financing Agreement
  - May 9<sup>th</sup> City Council to consider (second reading) Development Agreement/Financing Agreement
- The master developer is working on a marketing plan for the redevelopment of the Bleachery site including a "fly through" video. A redevelopment preview event "From Textile to Tech-Style" is scheduled for May 23<sup>rd</sup> at 2:00 pm.
- An application for a Brownfield Loan provided through the Catawba Council of Governments
  was filed and was approved. The loan will help the master developer lower the overall cost of
  abating lead-based paint and asbestos within the Lowenstein Building and the 1939 Building.
- Visits to learn about the development and operation of co-work facilities, business accelerators, and business incubator facilities were completed in Charleston, SC (April 13<sup>th</sup> and 14<sup>th</sup>) and a future trip to Greenville, SC is planned.

## IV. Committee Reports

Finance – Lee Gardner

The Finance Committee met on April 28.

## Consider Approval of RHEDC March 31, 2016 Financial Reports

The committee reviewed and approved the Statement of Financial Position for March 31, 2016, the March Budget Report, and the Innovation Challenge Grant report dated April 25, 2016.

The Finance Committee presented a motion to approve the Statement of Financial Position for March 31, 2016, the March Budget Report, and the Innovation Challenge Grant report. The motion was unanimously approved.

#### **Update on the Waterford Spec Building #2**

- Santee Cooper Loan Closing closing is expected to be on or before May 16th, and we will begin construction immediately thereafter.
- RHEDC entered into a fixed price construction contract with J. M. Cope on May 7, 2015. Andrew
  Cope, President of J. M. Cope, presented an update on the project schedule and pricing. He
  explained that due to a robust construction climate he expects some cost increases and potential
  shipping delays with concrete and concrete panels. He is working to acquire concrete from an
  alternate vendor. He anticipates the project being completed within the allocated budget, during
  4th quarter of 2016.
- Prospective buyers are already expressing interest in the new building.

## **Update on Legacy West Business Park**

In April 2016 the RHEDC Board approved the Development Agreement between RHEDC and Scannell. Key points of the Development Agreement:

- RHEDC to receive assignment of contracts and options to purchase 3 tracts of land totaling about 94 acres
- RHEDC to close on purchase of 2 tracts, totaling about 79 acres by June 27, 2016, net cost to RHEDC of approximately \$1.3 million
- Scannell to purchase from RHEDC 2 building sites totaling about 42 acres by July 29 and start construction of two spec industrial buildings
- RHEDC to seek grants to support infrastructure development of the sites
- Scannell to fund infrastructure costs above the amounts provided by grants

- Scannell to manage infrastructure construction
- Scannell to acquire all tracts from RHEDC within 3 years
- RHEDC expects to generate up to \$400,000 in cash to help fund future investments in business park sites
- Scannell and RHEDC to work cooperatively to plan the development of the 300 acre Legacy Park East development

Mr. Gardner reported that RHEDC completed the closing on Parcel F (44.07 acres, with 41.89 usable acres) owned by the Williams family on Tuesday, April 26th. Per the executed development agreement, RHEDC contributed cash of \$360,785.30 to the closing. The next closing (Parcel A, 18.55 usable acres and 13.161 unusable acres) will occur on or before June 27, 2016.

Mr. Gardner also provided an update on the Santee Cooper Site Readiness Grant. With the completed closing on the first parcel, RHEDC became eligible to submit the grant application. The application was submitted on April 29th.

## Consider Proposal for New Signage at TechPark

The Committee reviewed a proposal submitted by the TechPark Property Owners Association for new signage at the two Dave Lyle Boulevard entrances to the park and for new directory signs within the park. Design for the new signs will be consistent with the TechPark sign on Anderson Road. The projected cost for the new signs is \$52,586.44. The TechPark POA is considering using \$15,586.44 of cash reserves to contribute to the cost, and then issuing a special assessment to fund the remaining \$37,000.

## Quality of Life – Luanne Kokolis

The Quality of Life Committee met on April 5 and reviewed 10 proposals from students for a public art installation at the new White Street roundabout. The committee will report back to the board at the June meeting and present the selected design

# **Community Interest Presentation**

Dr. Julie Marshall, Saluda Trail Middle School

Dr. Marshall reported on her experience over the past two years in coaching STEAM student teams at Saluda Trail Middle School in the Business Model Competition, sponsored by the Technology Incubator @ Knowledge Park. Explaining that the "design cycle" is how they teach, the Business Model Competition provided collapsed time frames for the students to perform, adding real life pressure and intensity that they normally don't get in the classroom. The Business Model Canvas used in the competition, was a valuable teaching tool for students to collaborate to get their ideas on paper. For the students overall, the entire experience made them feel part of what is happening in Knowledge Park, and for many, changed their paradigms about the future of Rock Hill.
