Tourism Coordinator's Report - Wendy Hill

- Four reimbursements from the 2018-2019 65% Grant Fund were processed since the March 20 Commission meeting. The Arts Council of York County and ChristmasVille requested and received their full grant amount. Historic White Home and the Yap Iswa Festival requested partial reimbursements and will turn in an additional reimbursement request prior to cycle-end.
- Three economic impact event estimations were completed:
 Rock & Roll Wheelchair Tennis Classic at \$ 3,554; the BMX Carolina Nationals at just over \$2,000,000 and the Carolina Champions Soccer League event at nearly

\$337,000.

- PRT is receiving contracts from the 2019 Host Hotels for the USA Volleyball Palmetto Region events expected in 2020 and 2021.

OLD BUSINESS:

2019-2020 ATAX Grant Cycle:

- Commissioners met for a fourth and final discussion regarding the 65% Grant Recommendations for the 2019-2020 ATAX Grant Cycle.
- Upon a motion duly made and seconded, recommendations for 21 applicants were approved by the Commission. The recommendations will move forward to City Council for final approval in May or June. See Exhibit A – 65% Fund.
- The 2019-2020 Accommodations Tax Grant recommendation for the 30% Advertising & Promotions Special Fund will be forwarded to the Commission via email for their approval of proposed expenditures.
