MINUTES: The January 15, 2020, meeting minutes were approved as presented.

STAFF HIGHLIGHT: Katie Varnadore, Office Administrator – Rock Hill Sports & Event Center

Katie interned at Cherry Park for two summers while attending college. After graduation, she worked part time as a Concessions Supervisor before moving downtown to City Hall as PRT's Front Desk Office Assistant. She is now the Office Administrator at the new Sports & Event Center. While she is the first point of contact at the facility, her duties go well beyond greeting customers and registration. She assists with many things – from concessions to site supervising on weekends.

2020-2021 ATAX GRANT APPLICANT PRESENTATION – Arts Council of York County

Debra Heintz, Executive Director, made a presentation to the Tourism Commission to define the Arts Council's role in tourism. Organized in 1978, the Center for the Arts has resided in its current location for the past 24 years. Its mission is to create programming that encourages education, economic development and arts_advocacy through unique art experiences that help make York County a regional art destination with numerous avenues for art exploration - such as the Underexposed Film Festival of York County, Blues & Jazz, Ag and Art Tour (with SC being the largest free farm and art tour in the United States), literary and art competitions for all ages, art classes, musical events and eight galleries in Rock Hill that are managed by the Arts Council. With a number of art studios in the city, there are nearly 60 artists working in the downtown area. The arts are growing in Rock Hill as is evident with the South Carolina Arts Commission naming downtown Rock Hill as the first state-recognized cultural district in South Carolina in 2015. A study conducted in 2016

determined the arts in SC is a \$27 million industry, supporting 846 full time equivalent jobs and generating \$2 million in local and state government revenue. In 2019, there were 128,144 attendees from 176 cities, 34 states and five countries visiting various art venues and events in Rock Hill and York County. The Arts Council will be applying for Accommodations Tax Grant Funding in the 2020-2021 Grant Cycle.

Tourism Coordinator's Report - Wendy Hill

Accommodations Tax:

- 2018-2019 Grant Cycle: Remaining 65% funds plus interest accrued in the amount of \$7,433 were reallocated to the 30% Marketing and Promotion Fund at the recommendation of the Tourism Commission (September 2019) and approval from City Council on February 10, 2020.
- 2019-2020 Grant Cycle: To date, five reimbursements have been made with all applicants receiving their full grant amounts:

Visit York County (Convention & Visitors Bureau) - \$112,610 ChristmasVille - \$ 17,125 City of Rock Hill 2019 UCI BMX SX World Cup - \$38,530 Old Town Ice Rink - \$ 1,952 US Disc Golf Championship - \$ 9,557

-2020-2021 Grant Cycle:

There have been 17 applicants who have fulfilled their required meeting with PRT Staff/Commissioners as of February 18. The Sports Commission and PRT will schedule their meetings soon.

- All applications are due on Friday, March 6, 2020, by 5 PM (or postmarked by same).

Economic Impact:

- Two studies have been completed – both for events held at the Rock Hill Sports & Event Center:

Carolina One Volleyball – January 3-6 with an estimated event impact of \$ 732,114 Twister Gymnastics – January 24-26 with an estimated event impact of \$ 94,238.
