EXECUTIVE SESSION

Upon a motion by Councilmember Reno, which was duly seconded and unanimously approved, the Council went into Executive Session to discuss two matters not on tonight's agenda which were to discuss negotiations incident to proposed contractual arrangements concerning a potential amendment or amendments of an existing agreement related to property in the downtown area and to receive background information and legal information and legal advice concerning a potential zoning dispute involving property near the eastern area of the City limits.

SPECIAL SESSION - 6:00 P.M.

Council met in special session with Mayor Gettys, Mayor Pro Tem Pender and Councilmembers Black, Jackson, Lindsay, Reno, and Sutton. Also present were City Manager David Vehaun, Deputy City Manager Jimmy Bagley, Deputy City Manager Steven Gibson, City Attorney Paul Dillingham, and Municipal Clerk Anne P. Harty. No members of the media were in attendance.

HELD PUBLIC HEARING ON THE FY 2020/2021 BUDGET AND RELATED ITEMS

Pursuant to State law (Section 6-1-80) the City Council held a public hearing on the FY 2020/2021 Budget and related items. This second public hearing was advertised with the adjustment in sanitation revenues to continue residential curbside recycling. Citizens were given an opportunity to provide input on the proposed budget.

David Vehaun, City Manager, presented the item to the City Council and to the Public.

An ordinance entitled TO PROVIDE FOR THE DISPOSITION BY SALE OF PROPERTY ON DAVE LYLE BOULEVARD, ROCK HILL, SOUTH CAROLINA BY THE CITY OF ROCK HILL TO ROCK HILL ECONOMIC DEVELOPMENT CORPORATION, was given second reading and adopted upon a motion by Councilmember Pender, which was duly seconded and approved upon a vote of 5-2, with Councilmembers Jackson and Sutton dissenting.

Minor changes to the form of contract were made since first reading to help facilitate the assignment of the contract to a third party developer including additional details regarding the property description, including a per acre purchase price for the development parcel, conditions to such assignment and changes to some of the terms of the contract if all or a portion of it are assigned to a third party developer. City Attorney and City Staff recommended approval.

Paul Dillingham, City Attorney, presented the item to the City Council.

First reading of this ordinance included a motion with a \$0.78 per month increase to the average residential customer to maintain curbside recycling service. The ordinance reflects removal of the \$60 bulky item charge.

An ordinance entitled ORDINANCE TO RAISE REVENUE, ADOPT A BUDGET AND WORK PROGRAM FOR THE CITY OF ROCK HILL, S.C. FOR THE FISCAL YEAR ENDING JUNE 30, 2021, AND TO AUTHORIZE THE ISSUANCE OF TAX ANTICIPATION NOTES FROM TIME TO TIME DURING THE FISCAL YEAR 2020/2021, was given second reading and adopted upon a motion by Councilmember Reno, which was duly seconded and unanimously approved.

There have been no changes to the ordinance since first reading.

ORDINANCE TO APPROVE THE REDEVELOPMENT AGREEMENT BETWEEN THE CITY OF ROCK HILL AND CATALYST CAPITAL PARTNERS, LLC AND AUTHORIZE CERTAIN CITY OFFICIALS TO EXECUTE AND DELIVER THE REDEVELOPMENT AGREEMENT – Adopted

Mayor Gettys recused himself from this item due to a potential conflict of interest and turned the gavel over to Mayor Pro Tem Pender. An official copy of his statement has been made a part of these minutes.

An ordinance entitled ORDINANCE TO APPROVE THE REDEVELOPMENT AGREEMENT BETWEEN THE CITY OF ROCK HILL AND CATALYST CAPITAL PARTNERS, LLC AND AUTHORIZE CERTAIN CITY OFFICIALS TO EXECUTE AND DELIVER THE REDEVELOPMENT AGREEMENT, was given second reading and adopted upon a motion by Councilmember Reno, which was duly seconded and approved upon a vote of 6-0, with Mayor Gettys recusing.

Since first reading there have been a number of edits to the agreement with Catalyst Capital Partners, LLC as shown on the attached redline document. The only significant change is the addition of Section 31, which requires that the developer cooperate with the City's economic development consultant, National Development Council (NDC), to allow NDC to complete due diligence activities on behalf of the City. Upon approval of the item Mayor Pro Tem Pender returned the gavel to Mayor Gettys.

This Ordinance enables the abandonment of a utility easement within a roadway that was never built. The landowner has requested the abandonment to facilitate future development of the property. The City Attorney recommended approval of this ordinance.

Upon a motion by Councilmember Sutton, which was duly seconded and unanimously approved, approved Planning Commission recommendation regarding Petition M-2020-12 by Joseph Marin to rezone approximately 2.2 acres at 1918 Hilltop, 2154 & 2164 Celanese Road, and adjacent Right-of-Way from Residential Conservation District I (RC-I) and Business Development District I (BD-I) in York County to Neighborhood Commercial (NC). The subject properties are proposed to be annexed into the City of Rock Hill. Tax Parcels 634-11-03-011 To -013.

The applicant requested annexation and rezoning in order to facilitate the development of a restaurant without alcohol sales on the property. Staff recommended the proposed conditional use in the Neighborhood Commercial (NC) zoning district if certain use-specific standards can be met, including a setback standard. The applicant will request a variance from the Zoning Board of Appeals on this setback standard. The Planning Commission recommended approval of the proposed NC zoning at their June meeting by a vote of 6-1 (Martens opposed).

Dennis Fields, Planner II, presented the item to the City Council.

APPROVED A PETITION FOR ANNEXATION TO THE CITY OF ROCK HILL OF CELANESE ROAD/HILLTOP ROAD AREA II LYING ADJACENT TO THE CITY LIMITS OF THE CITY OF ROCK HILL, S.C. AS SHOWN ON MAP DATED JUNE 3, 2020

Upon a motion by Councilmember Sutton, which was duly seconded and unanimously approved, approved a Petition for Annexation to the City of Rock Hill of Celanese Road/Hilltop Road Area II lying adjacent to the city limits of the City of Rock Hill, S.C. as shown on map dated June 3, 2020. This is the annexation petition for the property at the corner of Celanese Road and Hilltop Road.

Dennis Fields, Planner II, presented the item to the City Council.

Upon a motion by Councilmember Reno, which was duly seconded and unanimously approved, approved Planning Commission recommendation regarding Petition M-2020-13 by Truck of Love (Susan Fullerton) to rezone approximately 0.9 acres at 1556, 1558, & 1568 West Main Street and adjacent Right-of-Way from Single-Family Residential-3 (SF-3) to Neighborhood Office (NO). Tax Parcels 595-02-01-001 To -003.

The applicant is requesting the rezoning in order to operate a homeless shelter for women on the property. This use is classified as a Group Home, Type A, and is a Special Exception in the Neighborhood Office (NO) zoning district. The buildings on the site would be renovated and used for the facility. The main building would serve as the shelter and the outbuildings would be used for office and meeting space. The applicant has yet to provide a site plan indicating minor changes to include parking. Assuming favorable first reading, this will be

provided for City Council consideration at second reading. In addition to the Special Exception for the proposed use, the applicant will need to apply for a Special Exception to reduce the required separation from another group home (3,000 feet required, with 2,760 feet provided), along with variances from the minimum lot size for group homes (43,560 square feet required, with 33,585 square feet provided), setbacks, and buffers.

The Planning Commission recommended approval of the rezoning at their June meeting by a vote of 7-0.

Susan Fullerton, Truck of Love, addressed the City Council. Eric Hawkins, Planner III, presented the item to the City Council.

Eric Hawkins, Planner III, presented the item to the City Council.

AWARDED BID FOR THE AIRPORT TERMINAL BUILDING EXPANSION IN THE AMOUNT OF \$536,658 TO EDISON FOARD INCORPORATED

Upon a motion by Councilmember Reno, which was duly seconded and unanimously approved, approved bid for the Airport terminal building expansion in the amount of \$536,658 to Edison Foard Incorporated.

In conjunction with the Airport Layout Plan Update, this project includes the expansion of the aviation terminal building to allow for additional office space, and other improvements including the replacement of two security access doors, and enclosing a staircase for safety reasons. The total cost including engineering, design, and construction is estimated to be \$834,717. Low bidder for the construction portion of the project is Edison Foard for \$536,658. The City contribution of \$87,923 is included in the FY2021 recommended budget. Construction is estimated to take 120 calendar days.

Jeremy Winkler, Intergovernmental Manager, presented the item to the City Council.

APPROVED APPROPRIATING RETAINED EARNINGS TO FUND YEAR END EXPENSES, IF NECESSARY, AND TO ASSIGN FUND BALANCE AS APPROPRIATE

Upon a motion by Councilmember Sutton, which was duly seconded and unanimously approved, approved appropriating retained earnings to fund year end expenses, if necessary, and to assign fund balance as appropriate.

As the end of the fiscal year approaches, the influence of many factors can still affect the year-end bottom line. Uncertainties and complexities in expenditures, particularly purchased power, and revenue receipts make it extremely difficult to predict exact year-end figures. At the end of each fiscal year, the City Council is asked to authorize the City Manager to appropriate from the City's retained earnings revenue necessary for the current fiscal year, and also assign fund balance for any dedicated revenues on hand at year end. Staff recommended approval.

David Vehaun, City Manager, presented the item to the City Council.
