

ROCK HILL TRAFFIC COMMISSION MINUTES

October 21, 2020 at 10:30 a.m. City Hall, City Council Chambers SUMMARY MINUTES

1. **Welcome:** Ms. Pender called the meeting to order at 10:37 A.M. and welcomed everyone in attendance.

2. <u>Minutes approval of August 19, 2020</u>: Ms. Pender asked if there were any additions, corrections or deletions from the August 2020 meeting. Hearing none, the minutes were approved as presented.

4. Old Business:

- A. Holly Hills Neighborhood Mr. Goolsby provided an update regarding the installation undergoing of speed humps within the Holly Hills neighborhood. He explained some questions from the HOA president were received about some of the characteristics of the speed humps and further noted the humps already installed have been evaluated and confirmed to being installed according to specifications.
- B. Herlong Ave @ India Hook Rd/Hamptonwood Rd Mr. Feemster provided follow up regarding the discussion from the previous meeting on the appropriateness of the speed limit remaining at 40mph. He also advised the traffic commission of SCDOT's plan to have an additional signal head installed as part of the traffic signal at this intersection.
- C. Pinewood Rd (Spencer Estates) Mr. Goolsby shared that City Council passed an ordinance establishing restrictions on thru trucks traveling on Pinewood Road in March of 2020 and the appropriate signage has now been posted.

5. New Business:

- A. Downtown Traffic Management Project Mr. Walsh provided a presentation highlighting recommendations for additions to the project. Discussion followed about the benefits and drawbacks that could be experienced if each were implemented. Mr. Goolsby made a motion to recommend to City Council the project be adjusted to include all of the presented recommendations. The motions received a second and passed unanimously.
- B. Transportation Safety Ms. Brown shared with the traffic commission that City Management is investigating traffic safety across the city with a focus on improvements to address traffic concerns,

which may include process changes to how the traffic commission functions, such as adjustments to the City's Traffic Calming policy.

- C. Dave Lyle Blvd @ Meeting Blvd Mr. Nealy described a consistent rutting/maintenance challenge existing at the intersection of Dave Lyle Blvd and Meeting Blvd and described some options that could be undertook to address the situation. He identified Dave Lyle Blvd as maintained by SCDOT and Meeting Blvd as maintained by the City. It was explained that the area of concern is located along the right-of-way boundary of the two. Discussion followed including input from Mr. Feemster on the possibilities being considered. Public Works will address the situation.
- D. Alexander Road @ Glendale Dr (Fewell Park Neighborhood) Mr. Goolsby described a concern received from a resident regarding speeding in the Fewell Park neighborhood as well as the maintenance of road striping on Alexander Rd at the intersection of Glendale Dr. Discussion occurred on what speed limit signing exists in the neighborhood where the commission asked staff to coordinate with SCDOT to ensure the area is signed properly. Mr. Goolsby then advised those present of earlier action taken by Traffic Commission to address a previous concern at this intersection where additional pavement markings and raised pavement markers were used to better delineate the appropriate traffic movement turning from Alexander Rd onto Glendale Dr. It was noted that SCDOT and the City maintain roads within this neighborhood and the previous actions taken were done with approval from SCDOT. Public Works will update the pavement markings and raised pavement markers as their schedule permits.
