

Neighborhood and Street/Block Party Registration

A Neighborhood Block Party is an outdoor public party organized by the residents of a neighborhood using sidewalks/streets requiring no city services.

In the interest of public safety, it is important to register your neighborhood and street/block parties with the City of Rock Hill. The registration forms serves to verify approval by the neighborhood at large and to alert emergency services of potential road blockages.

Guidelines and Considerations:

- Verification of neighborhood approval must be submitted to the City Manager's office in writing. Neighbors should include their names, addresses, phone numbers and signatures on a form to confirm that 75% of the neighborhood is in agreement with the event.
- Complaints of loud, disturbing, or unnecessary noise can result in a fine to the applicant if appropriate adjustments are not met. See the City's Noise Ordinance (Sec. 20-161 and 162 of the Rock Hill Code of Ordinances) for more information.
- The consumption of alcohol is prohibited in streets and public rights of way.
- Fire hydrants and sidewalk curb breaks intended for ADA accessibility may not be blocked at any time.
- A minimum 15 foot emergency access lane (approximately one regular road lane) must remain open throughout the event site at all times.
- Applicants are responsible for cleaning and restoring the site after the event. Cleanup of public property will be held to the standards set by the City of Rock Hill.
