The City has undertaken a comprehensive self-evaluation of its programs, services, and activities over the past several years to determine the extent that individuals with disabilities may be restricted in their access. Through this resolution, the City maintains compliance with the Americans with Disabilities Act (ADA) and promotes the maintenance and repairs of public facilities.

### <u>APPROVED APPROPRIATING RETAINED HEARING TO FUND YEAR END</u> EXPENSES, IF NECESSARY, AND TO ASSIGN FUND BALANCE AS APPROPRIATE

Upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved, approved appropriating retained earnings to fund year end expenses, if necessary, and to assign fund balance as appropriate.

As the end of the fiscal year approaches, the influence of many factors can still affect the year-end bottom line. Uncertainties and complexities in expenditures, particularly purchased power and revenue receipts, make it extremely difficult to predict exact year-end figures. At the end of each fiscal year, the City Council is asked to authorize the City Manager to appropriate from the City's retained earning revenue necessary for the current fiscal year, and also assign fund balance for any dedicated revenues on hand at year end. At this time, we do not expect any use of retained earnings for this purpose. Staff recommended approval.

David Vehaun, City Manager, presented the item to the City Council.

### APPROVED CANCELLING CITY COUNCIL MEETINGS FOR THE MONTH OF JULY 2023

Upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved, approved cancelling City Council meetings for the month of July 2023.
