# TO THE CITY LIMITS OF THE CITY OF ROCK HILL, S.C. – Adopted

An ordinance entitled AN ORDINANCE TO AMEND CHAPTER 7, ANNEXATIONS, OF THE CODE OF THE CITY OF ROCK HILL, SO AS TO PROVIDE FOR THE ANNEXATION, ZONING, AND WARD DESIGNATION OF WEST MAIN STREET/RAWLINSON ROAD AREA II LYING ADJACENT TO THE CITY LIMITS OF THE CITY OF ROCK HILL, S.C. was given second reading and adopted upon a motion by Councilmember Black with condition that the demolition of the Burger King building and infrastructure construction run concurrently within the next six months, which was duly seconded and approved upon a vote of 6-1 with Councilmember Reno dissenting.

In consultation with the City Attorney, staff recommended the zoning designation be changed from RSF-40 in York County to MP-R for the unincorporated area where the townhomes are proposed to be located. The proposed commercial space that fronts Main Street is already in the City limits and therefore, not included in this annexation ordinance. The MP-R zoning proposed for the townhomes will provide better protections for the surrounding neighborhoods.

This ordinance requires reciprocal and proper arrangements for the transportation and drop-off of certain at-risk persons within the City limits. Community agencies and the RHPD assisted City staff with this proposal. The City Manager and City Attorney recommended approval.

# APPROVED FAÇADE REHABILITATION GRANT PROGRAM APPLICATION FOR 538 SOUTH DAVE LYLE BOULEVARD

Upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved, approved a Façade Rehabilitation Grant Program application for 538 South Dave Lyle Boulevard.

The proposed façade application seeks to support exterior improvements at the former African American Insurance Building. The intended new use of the building is a co-productivity hub for new and growing entrepreneurs. A 25% reimbursement of \$10,121 was requested based on the total estimated cost of \$40,485. The grant will be reimbursed based on paid receipts. The property is located just outside the Southside TIF. Staff brought the application to City Council for consideration because of the property's location, future use and ability to positively affect Clinton Connextion and Southside TIF redevelopment.

#### RE-ELECTED COUNCILMEMBER LINDSAY AS MAYOR PRO TEM
