Once approved, the loan terms will be attached to the ordinance at second reading. A loan approval with an interest rate of 2.1% and a twenty-year term is anticipated. Council's November 2023 utility work session and the recent utility rating process included this capital project.

Anne Harty, CFO, Finance, presented the item to the City Council.

The City has received an \$8 million grant which will supplement this project cost. Additionally, the recent utility bond included another \$3 million for this project. Once approved, the loan terms will be attached to the ordinance at second reading. A loan approval with an interest rate of 2.1% and a twenty-year term is anticipated. Council's FY24 budget process, the November 2023 utility work session, and the recent utility rating process included review of this capital project.

Anne Harty, CFO, Finance, presented the item to the City Council.

APPROVED CITY OF ROCK HILL RESOLUTION TO CERTIFY PROPERTY AT 167 LEE STREET, ROCK HILL, SC AS AN ABANDONED TEXTILE MILL SITE

Upon a motion by Councilmember Reno, which was duly seconded and unanimously approved, approved City of Rock Hill Resolution to Certify Property at 167 Lee Street, Rock Hill, SC as an Abandoned Textile Mill Site.

This resolution enables certain tax credit options under the South Carolina Textile Communities Revitalization Act. The Act requires that the City Council pass a resolution certifying that the planned development is located on the site of a former textile mill that meets certain criteria under state law. There is no cost or liability for the City related to this certification. Staff recommended approval.

Paul Dillingham, City Attorney, presented the item to the City Council.

ANNOUNCED SMARTSWITCH AND CUSTOMERCONNECT WINNERS
