Upon a motion by Councilmember P. Sutton, which was duly seconded and unanimously approved, presented a proclamation to recognize Dale Hoyles for heroic efforts in saving the occupants of 315 Summit Street from a house fire.

Mr. Hoyles addressed the City Council.

Barbara Patterson, family member of the occupants of 315 Summit Street, addressed the City Council.

ORDINANCE TO PROVIDE FOR THE LEASE OF SPACE AT THE AIRPORT FROM THE CITY OF ROCK HILL TO TAXIWAY J, INC. – First Reading

An ordinance entitled AN ORDINANCE TO PROVIDE FOR THE LEASE OF SPACE AT THE AIRPORT FROM THE CITY OF ROCK HILL TO TAXIWAY J, INC. was given first reading upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved.

The Master Hangar Area Lease is for a twenty-five year term, with right to extend for an additional fifteen years, of approximately 5.74 acres at the Airport containing fifty-nine hangar units. The lease is modeled after existing least agreements and will replace leases terminating on December 31, 2024. The initial rent is \$20,319 per year with annual CPI increases. The City will own the hangars at the end of the lease term. The current hangar tenants will sublease their respective hangars from Taxiway J. This lease will benefit the City through continued Airport use and real/personal property taxes. Staff recommended approval.

Steven Gould, Director, Airport, presented the item to the City Council.

Gardy Wilson, President of Taxiway J Hangar Owners Association, addressed the City Council.

ORDINANCE FOR ABANDONMENT OF UTILITY RIGHTS OF WAY AND EASEMENTS ON PROPERTY LOCATED ON CEL-RIVER ROAD IN THE CITY OF ROCK

HILL – First Reading

An ordinance entitled AN ORDINANCE FOR ABANDONMENT OF UTILITY RIGHTS OF WAY AND EASEMENTS ON PROPERTY LOCATED ON CEL-RIVER ROAD IN THE CITY OF ROCK HILL was given first reading upon a motion by Councilmember Reno, which was duly seconded and unanimously approved.

The property at 211 Cel-River Road, owned by Randolph Yarns II Land Investor Holdings LLC, requires an all-inclusive easement abandonment for the South Carolina Department of Transportation (SCDOT) Cel-River Road widening project. The original easement was recorded before SCDOT made changes to the project; the new easement is needed to reflect these changes. No new easements are required at this time. Staff recommended approval.

As this feed was not needed, the owner would like to abandon the electric easement to develop the property. No new easements are required at this time. Staff recommended approval.

Latif Taheri-Azar would like to purchase the two City-owned properties at 711 and 721 Green Street for development. Staff recommended approval.

ORDINANCE FOR PARTIAL ABANDONMENT OF UTILITY RIGHTS OF WAY AND EASEMENTS ON PROPERTY LOCATED ON LEE STREET IN THE CITY OF ROCK HILL – First Reading

An ordinance entitled AN ORDINANCE FOR PARTIAL ABANDONMENT OF UTILITY RIGHTS OF WAY AND EASEMENTS ON PROPERTY LOCATED ON LEE STREET IN THE CITY OF ROCK HILL was given first reading upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved.

This ordinance provides for the full abandonment of the old Lee Street roadway, partial abandonment of North Lee Street, and abandonment of three partial easements for the first phase of the new 40,000 square foot sports facility located near 605 West White Street. The property will be owned by the City of Rock Hill and Southern Steet Development. Future phases include commercial, retail, and townhome development. Staff recommended approval. Jimmy Bagley, Deputy City Manager, presented the item to the City Council.

APPROVED PLANNING COMMISSION RECOMMENDATION ON PETITION M-2024-10 BY FOUR CORNERS OF CHARLOTTE, LLC (TYSON HAEFELE) TO REZONE APPROXIMATELY 2.31 ACRES AT 875 ORR DRIVE FROM SINGLE-FAMILY RESIDENTIAL 3 (SF-3) TO SINGLE-FAMILY RESIDENTIAL-5 (SF-5). TAX PARCEL 600-21-05-002

Upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved, approved Planning Commission recommendation on petition M-2024-10 by Four Corners of Charlotte, LLC (Tyson Haefele) to rezone approximately 2.31 acres at 875 Orr Drive from Single Family Residential-3 (SF-3) to Single Family Residential-5 (SF-5). Tax Parcel 600-21-05-002.

The applicant, Four Corners of Charlotte, LLC, is requesting rezoning from Single-Family Residential-3 (SF-3) to Single-Family Residential-5 (SF-5) for the development of the property into six single-family detached lots. Prior to construction, the developer will be required to complete Orr Drive. The Planning Commission recommended approval of SF-5 zoning at their July 9, 2024 meeting by a vote of 4-0 (Goodner recused; Christopher and Nazeer absent).

Shana Marshburn, Planner III, Planning & Development, presented the item to the City Council.

ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROCK HILL CODE BY MAKING CERTAIN CHANGES IN THE OFFICIAL ZONING MAP AFFECTING APPROXIMATELY 2.31 ACRES FROM SINGLE FAMILY RESIDENTIAL-3 (SF-3) TO SINGLE FAMILY RESIDENTIAL-5 (SF-5) – First Reading

An ordinance entitled AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF

THE CITY OF ROCK HILL CODE BY MAKING CERTAIN CHANGES IN THE OFFICIAL ZONING MAP AFFECTING APPROXIMATELY 2.31 ACRES FROM SINGLE FAMILY RESIDENTIAL-3 (SF-3) TO SINGLE FAMILY RESIDENTIAL-5 (SF-5) was given first reading upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved.

This ordinance will enact the SF-5 zoning on the property as recommended by the Planning Commission.

Shana Marshburn, Planner III, Planning & Development, presented the item to the City Council.

APPROVED PLANNING COMMISSION RECOMMENDATION TO AMEND THE ZONING ORDINANCE STANDARDS RELATED TO PARKING IN CHAPTER 8: DEVELOPMENT STANDARDS

Upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved, approved Planning Commission recommendation to amend the Zoning Ordinance standards related to parking in Chapter 8: Development Standards.

The proposed amendments would bring the City's requirements with regards to parking in the Downtown area in line with several peer jurisdictions. The amendments include an automatic 20% reduction for all non-residential land uses and allow developers to request additional reductions in the required number of parking spaces from specific non-residential uses and multi-family uses up to a specific threshold. The Planning Commission recommended approval of the amendments at their July 9, 2024 meeting by a vote of 5-0 (Christopher and Nazeer absent).

Leah Youngblood, Director, Planning & Development, presented the item to the City Council.

ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROCK HILL CODE, CHAPTER 8: DEVELOPMENT STANDARDS CONCERNING PARKING STANDARDS IN THE DOWNTOWN PARKING MANAGEMENT DISTRICT – First Reading

An ordinance entitled AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF ROCK HILL CODE, CHAPTER 8: DEVELOPMENT STANDARDS CONCERNING PARKING STANDARDS IN THE DOWNTOWN PARKING MANAGEMENT DISTRICT was given first reading upon a motion by Councilmember K. Sutton, which was duly seconded and unanimously approved.

This ordinance will amend Chapter 8: Development Standards of the Zoning Ordinance concerning Parking Standards in the Downtown Parking Management District as recommended by the Planning Commission.
